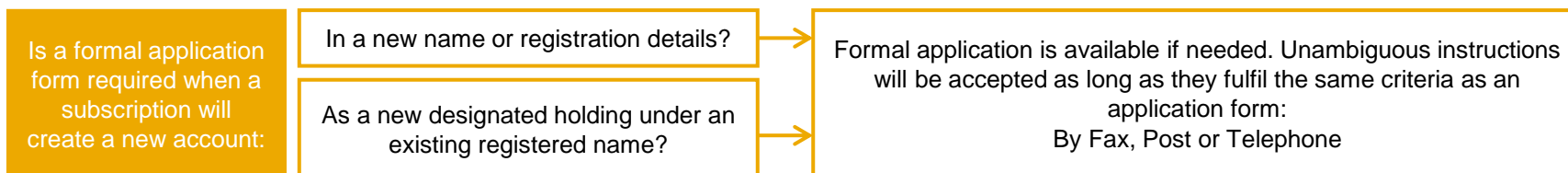


Please use the below criteria as a requirements guide when submitting an instruction to trade into a new unitholder account.
